INSTRUCTIONS

- 1) **(VARIETY)** if you are entering a dog of a breed in which there are varieties for show purposes, please designate the particular variety you are entering. i.e. Beagles (not exceeding 13 in., over 13 in.), Dachshunds (longhaired, smooth, wire-haired, standard, miniature, Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), Poodles (toy, miniature, standard).
- 2) **(Dog Show Class)** consult the classification listing in the premium. The dog must be of the proper age to enter the class (no "puppies" in open class).
- 3) A dog must be entered in the name of the person who actually owned it at the time entries for a show closed. If a registered dog has been acquired by a new owner, it must be entered in the name of its new owner in any show for which entries closed after the date of acquirement, regardless of whether the new owner had received the registration certificate indicating that the dog is recorded in his name.

AGREEMENT: I (we) acknowledge that the "Rules Applying to Registration and Dog Shows" has been made available to me (us), and that I am (we are) familiar with their contents. I (we) agree that the club holding this show has the right to refuse this entry for cause that the club shall deem to be sufficient. In consideration of the acceptance of this entry and of the holding of the show and of the opportunity to have the dog judged and to win prize money, ribbons, or trophies. I (we) agree to hold UNITED ALL BREED, INC., their members, directors, governors, officers, agents, superintendents or show secretary and the owner or lessor of the premises and any employees of the aforementioned parties, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or upon the show premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim. and I (we) further agree to hold the aforementioned parties harmless from any claim for loss of this dog by disappearance, theft, death or otherwise, and from any claim for damage or injury to the dog, whether such loss, disappearance, theft damage, or injury be caused or alleged to be caused by the negligence of the club or any of the parties aforementioned, or by the negligence of any other person, or any other cause or causes.
